Re: **Payments to Members of the Public Safety Personnel Retirement System for Excess Contributions, Plus Interest, a Result of the Hall-Parker Litigation Settlement**

As the Board recalls, in an attempt to reduce the fiscal impact of the rapidly escalating cost of the Public Safety Personnel Retirement System (PSPRS) the Legislature enacted legislation to increase the contributions of members. The members filed a lawsuit and the court held that the action of the Legislature was unconstitutional, requiring a refund with interest.

The legislation attempting to reduce the accelerated expense growth in the PSPRS as enacted by the Legislature in 2011 increased the employee portion of the PSPRS contribution from 7.65 percent to 11.65 percent (from 4.0 percent to 7.65 percent for eligible Pima County employees as the County pays 3.65 percent of the employee share.) In 2011, the County's required employer contribution to the PSPRS was only 26.51 percent. Since the statutory employee increase enacted in 2011, the County's required contribution to PSPRS increased to the current range of 53.49 percent to 67.16 percent based on the hire date of the employee. The litigation effectively reduced the employee contribution for those employees hired on or before July 19, 2011 back to 4.0 percent. It should be noted our regular employees enrolled in the Arizona State Retirement System have a current contribution rate of 11.50 percent which is nearly three times higher than the present retirement contribution rate for those public safety employees impacted by this litigation.

Recently, the court indicated interest payments should be based on 5.25 percent. I am enclosing a list of payments that will be made to the members of the Public Safety Retirement System, this would include their excess contribution as well as interest. These payments will be made on or before December 22, 2017 to the individuals listed.
