Re: **Ms. Geri Ottoboni Parking in County Administration's A Level Garage**

Supervisor Ally Miller has placed an item on the January 5, 2016 Addendum regarding special parking privileges for Ms. Geri Ottoboni in the A Level Garage of the County's Administration East Building. Unbeknownst to me, Ms. Ottoboni has been regularly parking in the A Level garage for some time; however, I also just learned this is a standing parking reservation directed by Supervisor Miller. The stated reason is due to a disability.

The Clerk of the Board's Meeting Agenda cover page regarding accessibility states:

"The Board Hearing Room is wheelchair and handicapped accessible. Any person who is in need of special services (e.g., assistive listening device, Braille or large print agenda material, signer for hearing impaired, accessible parking, etc.) due to any disability will be accommodated. Please contact the Clerk of the Board at (520) 724-8449 for these services at least three (3) business days prior to the Board Meeting."

I contacted Clerk of the Board Robin Brigode to determine whether Ms. Ottoboni or any other member of the public has ever contacted her office to request accessibility accommodations as instructed in the Meeting Agenda cover page. Ms. Brigode responded that she has not been contacted by Ms. Ottoboni or any other member of the public requesting special accessibility.

It would appear the parking privilege Supervisor Miller directed County Parking employees to implement is a favor not granted to members of the public and may be a violation of Pima County Code (see attached December 15, 2015 email from Supervisor Miller to Administrative Services Manager Jim Garrison). County Code 2.12.090 - Noninterference prohibits any member of the Board of Supervisors or the Supervisor's personal staff from giving orders to or instructing "...any officer or employee under the supervision of the county administrator except through the county administrator..." Such interference is a Class 1 Misdemeanor with penalties of up to six months imprisonment and/or up to a \$2,500 fine.

The El Presidio Garage is an Americans with Disabilities Act (ADA) compliant facility; and based on elevator access and a ramp to the Board of Supervisors Hearing Room from the garage, ADA is accessible.

I also contacted the City of Tucson regarding their accessible parking, and they indicated there are marked handicapped spaces that have pay meters installed.

As you know, A Level parking is reserved, and those individuals who park on A Level pay a monthly fee of \$70 through payroll deduction. Board members, Superior Court Judges, and all staff who park on A Level pay this fee. Parking is not free on A Level. Further, all of our employees who may require ADA accommodation also pay the full downtown monthly parking fee pursuant to Administrative Procedure 51-2.3.b.

I indicated Ms. Ottoboni is welcome to park in the El Presidio Garage with all other members of the public, as the El Presidio Garage is an ADA accessible facility with a pathway directly available to the Board Hearing Room.

I will be discussing this possible Code violation to the County Attorney.
