Re: **Road Repair Additional Allocation Analysis and Road List - Revised**

On October 11, 2019 you sent a memorandum to the Board of Supervisors titled *Road Repair Additional Allocation Analysis and Road List*. The attachment to that memorandum was my October 11, 2019 memorandum with the same title and a list of roads selected to be repaired with the proposed additional \$10 million. On October 14, 2019, your October 11, 2019 memorandum was resent to the Board of Supervisors with an updated list to correct a totaling error in the spreadsheet for the total mileage amount. The corrected mileage total increased the miles of road repaired from 32.02 miles to 39.18 miles. No other changes were made to the roads displayed in list.

Please find attached an updated road list to my October 11, 2019 memorandum of the same name. The updated attachment includes additional road segments in Supervisor Districts 3 and 5 which were previously omitted. The addition of the previous submitted roads brings the total number of miles repaired to 42.33 miles. Re: **Road Repair Additional Allocation Analysis and Road List**

Please see the attached October 11, 2019 memorandum from Assistant County Administrator for Public Works Yves Khawam providing an analysis and list of roads that would be repaired this year should the Board approve an additional \$10 million allocation of FY 2018/19 ending fund balance. The plan allocates \$2 million to local road segments in each supervisory district based on the "worst first" criteria approved by the Pima County Transportation Advisory Committee for selection of roads for repair this fiscal year.

While funding allocations are evenly distributed among districts, the total number of miles repaired for each district differ based on varying road widths resulting in mileage differentials. You might also notice that some of the selected local roads are industrial. Industrial local roads, like residential ones, are not grouped with arterials and collectors for classification and funding purposes.

The analysis demonstrates that this additional funding allocation allows us to accelerate progress in repairing our roads. As stated in my prior communications to you, I recommend the Board of Supervisors approve this additional funding allocation at the November 5, 2019 meeting.

Re: **Road Repair Additional Allocation Analysis and Road List**

Your November 5, 2019 Pay-As-You-Go (PAYGO) and Allocation of Unreserved Fund Balance memoranda recommend an additional \$10 million of FY 2018/19 ending fund balance be allocated to local road repair. This memorandum provides an analysis and list of roads that would be repaired should the Board of Supervisors approve this additional allocation.

A \$10 million additional allocation would raise the FY 2019/20 funding for road repair from \$26 million to \$36 million, an amount significantly exceeding annual budgets in the past two decades thereby accelerating the elimination of failed pavements. The table below replicates Table 2 budget amounts in my September 13, 2019 road repair analysis (attached) and adds columns demonstrating the impact that this additional \$10 million would have on the average network Pavement Condition Index (PCI).

The table shows that an additional \$10 million PAYGO allocation this fiscal year will result in an overall network PCI increase of 2 points, from 42 to 44 and a commensurate percentage improvement of 11 to 16 percent from FY 2018/19. The additional allocation would further accelerate pavement improvement and may retire the need for a General Fund PAYGO subsidy to Department of Transportation State-shared revenue funding in FY2028/29, one year earlier than previously reported.

Attached is a list of local failed road segments selected for repair if the recommended \$10 million allocation is approved. The segments were selected based on a \$2 million allocation per Board of Supervisor District using the "worst first" approach recommended by the Pima County Transportation Advisory Committee for road selection this fiscal year.
